

URMETALSVault OPERATIONS AND LIMITATIONS

URMETALSVault is an ecommerce website that is managed by Barbarroja Consulting Services on behalf of the Unalienable Rights Now Foundation. URMETALSVault through its management services, contracts and/or affiliates with licensed precious metals dealers, retailers, and storage facilities of precious metals. URMETALSVault will maintain bullion purchases, sales, and storage in accordance with properly licensed affiliates for independently verifiable auditing purposes and compliance with all State, Federal, and International laws and regulations.

Any individual wishing to store their independently purchased products from other vendors, where the chain of ownership cannot be verified by URMETALSVault to verified and licensed affiliates or dealers, will not be allowed to store their metals with any affiliate of URMETALSVault. URMETALSVault will not purchase or sell any bullion products directly to or from any company or individual unless the chain of ownership can be verified, and in accordance with any and all local licensing and regulatory requirements.

URMETALSVault will provide sales of bullion products that have been purchased, either through or from another verified and licensed distributor, or only from individuals where the entire chain of ownership can be verified through properly licensed and registered affiliates.

In accordance with the Bank Secrecy Act, Anti Money Laundering regulations, and KYC best practices, all account owners who do business directly with URMETALSVault, either as buyers or sellers, will be required to maintain current identification on file that verifies any customer shipping address, including but not limited to:

- Proof of Citizenship
- Social Security Identification
- Non-Expired Passport, Driver's License, or other Official Identification Card
- Utility statements showing at least 6 months of occupation by the recipient at the shipping address.

Specific policies relating to compliance with all State and Federal laws and regulations will be kept on file at the registered agent's office locally in Cheyenne, WY and any controlling member's primary business address.

Independent audit and AML compliance certification will be performed annually at a minimum to ensure compliance with all State and Federal laws and regulations. URMETALSVault will not engage in any activity other than the coordination of buying, selling, storing of physical bullion products, and providing independent software for tracking ownership.

URMETALSVault through its affiliates will ensure the maintenance of monetary account balances and precious metals storage balances in sufficient enough amounts and denominations as required and demanded by ownership of the balances. At no time will affiliates of URMETALSVault or any controlling member "float" any part of a transaction without having sufficient and physical monies and/or products on hand and within the full control of the licensed affiliates of URMETALSVault.

URMETALSVault IS NOT A MONEY SERVICES BUSINESS

URMETALSVault does not deal in monetized bullion products (precious metals in the form of currency that have a monetary mark) such as American Eagles or any other foreign coin or currency.

URMETALSVault does not hold securities or "e-certificates" for any customers and is strictly in the business of tracking the buying, selling, and storing physical precious metals for known customers in accordance with KYC best practices, and only through properly licensed affiliates.

URMETALSVault is not classified as an MSB. However, URMETALSVault believes it is best to have AML compliance and auditing in place for industry best practices and tracking of our affiliates. Any suspicious activity or transactions over industry accepted limits are referred to the proper reporting authorities for compliance.
